Continued Meeting of California Borough Council, June 25, 2019, 6:30 pm

PUBLIC COMMENT – Agenda Items

PRESIDENTS'S REPORT – MR. ALFANO

Mr. Alfano had nothing to report at this time.

BOROUGH ADMINISTRATOR – DR. MARTIN LENGTH RESTRICITON – WOOD ST.

Dr. Martin stated we need to revisit the issue to whether or not council wishes to request Penndot to put a 45' length restriction on vehicles on Wood St. He stated he gave council a full report by email concerning his discussions with Judge Kanalis, which he says basically as long as the tickets are written correctly he will enforce whatever we cite. HOLLOWOOD THEATRE PROPERTY

Dr. Martin stated the Redevelopment Authority is ready to transfer the former Hollowood Theatre property to the borough. They plan on recording the deed tomorrow. He stated it is a free and clear lot and they are paying everything to transfer and record the deed but they need a motion by council to accept the lot.

Dr. Martin stated Clair Mock is a senior at CASD and council has met her before, she was the alternate this passed year.

Motion by Bittner/Gutosky to approve Claire Mock as the junior council members carried with all members present stating aye.

APPROVE MR. BECKINGER AS ALTERNATE JUNIOR COUNCIL MEMBER

Dr. Martin stated the alternate junior council member who will take over as the Junior Council member next year is Jeremy Beckinger.

Motion by Bittner/Gutosky to approve Jeremy Beckinger as the alternate Junior Council member carried with all members present stating aye.

PUBLIC HOUSING - MR. GLAB

PUBLIC WORKS – MR. MARISCOTTI HUNTER'S BID FOR CURBS ON FOURTH STREET

Mr. Agrafiotis asked Council what their intentions are on awarding this bid. Mr. Difilippo stated we still don't have an answer on when Columbia Gas is going to be working on Fourth Street. Dr. Martin stated that meeting is scheduled for tomorrow at 1 pm.

Mr. Bittner stated Mr. Tuday stopped as his house today and stated his truck is in the shop and they gave him a price of \$2,900.00 to repair it. The check engine light kept coming on and he would like the approval of council to get it fixed. Dr. Martin stated this is the first he's hearing of it. Mr. Bittner stated understandable he didn't stop at my house until 5:00 pm this evening. Mr. Bittner stated Dr. Martin can speak to Jeff and get the details tomorrow morning.

Motion by Bittner/Difilippo to allocate up to \$2,900.00 to get the Street Dept. vehicle repaired duly carried on a roll call vote with all members present voting yes.
